Dogs competing for the **Rally Advanced Excellent title** should be entered in the **RAE** class (i.e., entered in both Advanced B and Excellent B, and the combined entry fee of \$46 for these two classes paid). If due to entry limits an exhibitor cannot be entered in both the Advanced B and Excellent B classes, the RAE class will be considered closed and any subsequent entries for this class will be unacceptable in their entirety.

Dogs competing for the **Rally Championship title** should be entered in the **RACH** class (i.e., entered in Advanced B, Excellent B, and the Master class and the combined entry fee of \$64 for these three classes paid). If due to entry limits an exhibitor cannot be entered in the Advanced B, Excellent B, and Master classes, the RACH class will be considered closed and any subsequent entries for this class will be unacceptable in their entirety.

The Trial Secretary will establish a wait list in order to fill openings created by entries that are withdrawn prior to the event closing date.

## Dog "Potty" Area, Smoking, Crates, Seating and Ring Matting

- 🐾 The *only* dog "potty" area is behind the CABTC building. *Please keep your dog off **any** grassy areas and help us keep our good relationships with our neighbors.*
- 🐾 Please refrain from smoking within 30' of any CABTC door.
- 🐾 There is plenty of space for your chairs & crates.
- 🐾 Please bring a waterproof pad to place under your chair and your dog's/dogs' crate(s).
- 🐾 Exercise pens are not permitted. All dogs who are not being warmed up, shown, or "pottied" must be securely crated.
- 🐾 The ring matting is ½ " rubber.

## Arbitration of Claims

Cleveland All-Breed Training Club, Inc. does not agree to arbitrate claims as set forth on the official AKC entry form for these events.

## Transfers

- 🐾 Any requests for Transfers prior to the trial weekend must be received by the Trial Secretary by 6 p.m. on Monday, June 17, 2024.
- 🐾 Any requests for Transfers prior to the Sunday trial must be received either (a) no later than 30 minutes after the last dog completes the Saturday trial or (b) no later than 45 minutes before the start of the Sunday morning trial.

## Class Order

Class order will be **ascending** from lowest to highest jump height (small to tall) in classes in which jumps are used. Please ensure that you have included your dog's jump height on the entry form.

## Directions to Trial Site

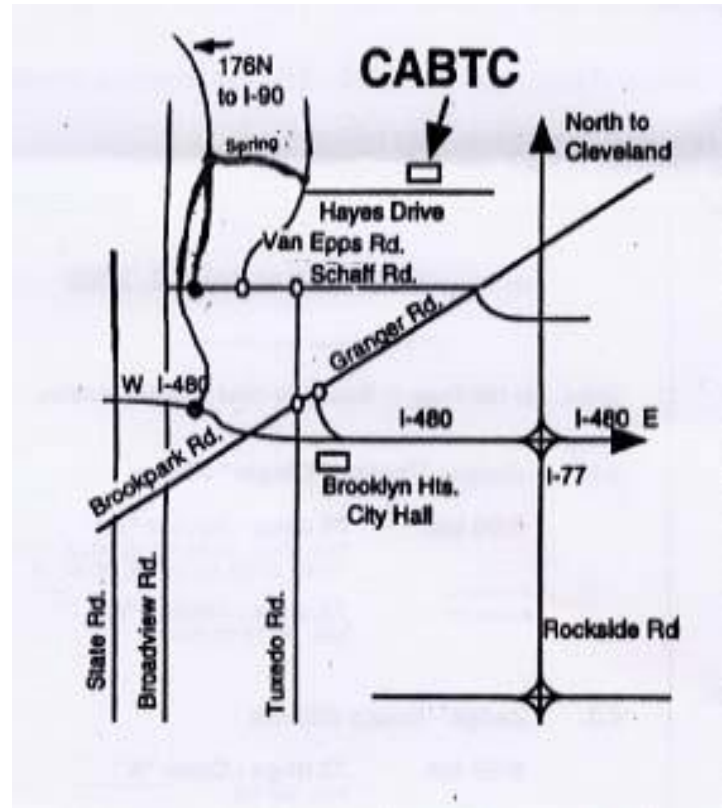
**From the West:** Take the Ohio Turnpike to Exit 15 which is the 480 Exit East. Take I-480 East to Route 176 North.

**From Route 176 North:** The very next exit is Spring Road/Hinckley Parkway. Turn right on to Spring Road/Hinckley Parkway. From Spring Road/Hinckley Parkway: Turn left on to Spring Road. Spring Road dead-ends at Van Epps (at the stop sign). Make a very slight right turn onto Van Epps. The next street is Hayes Drive. Turn left on to Hayes Drive. Note: if the blue Brilliant Electric Sign Co. sign is to your left, you have gone too far.

**From the East:** Via the Ohio Turnpike, get off at the I-77 exit. Follow the signs to I-77. Take I-77 North to I-480 West. Immediately get off at the Route 176 North/Brookpark exit. Stay on Route 176 North and then follow above directions

**From the South (and hotels):** Take I-77 North to I-480 West. Immediately get off at Route 176 North/Brookpark exit. Stay on Route 176 North and follow above directions from Route 176 North.

**From the North:** Take I-77 South to I-480 West. Immediately get off at the Route 176/Brookpark Exit. Stay on Route 176 North and follow above directions from Route 176 North.

**Mail all entries to Deborah Foster-Koch, Trial Secretary, 314 Hillsdale Circle, Wadsworth, OH 44281.** Entries close on **Wednesday, June 5, 2024 at noon** or when the maximum 8 hour judging time limit is met, after which time entries cannot be accepted, cancelled, altered or substituted, except as provided for in Chapter 11, Section 6 of the Dog Show Rules. *Hand-delivered entries cannot be accepted.*

**Make All Checks and Money Orders payable to the Cleveland All-Breed Training Club (CABTC).** Please mail checks or money orders with entries. Trial Secretary assumes no responsibility for cash sent through the mail. Please use black or blue ink on all checks.

**The following cannot be accepted:**

- Telephone, email, and *hand-delivered* entries.
- *Unsigned entries.*
- Entries not on official AKC entry forms, or photocopies of entry forms without agreement and rules on the reverse side of the official AKC entry form.
- Entries without fees.

Acknowledgment of entries will be made as soon as possible after they are received.

**If a legible email address is provided, judging program and confirmation of entry will be emailed.** Paper copies will only be mailed by request. Should acknowledgment not be received by the exhibitor within a reasonable time, please notify the Trial Secretary at 330-419-1807 or email [furrycritters@neo.rr.com](mailto:furrycritters@neo.rr.com).

**Postdated or returned checks do not constitute a valid entry fee.** CABTC will add a collection fee of \$25 to the amount of each returned check.

**No refund for duplicate entries.** Every effort will be made to find duplicate entries; however, if the entry has been processed, no refund will be made.

**Declination of entries.** No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. CABTC may decline any entry and may remove any dog because of disease, viciousness, or other cause, and no one shall have any claim against CABTC or any official thereof.

**Entry fees shall not be refunded** in the event a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Trial Committee. If because of riots, civil disturbances, or other acts beyond the control of the Trial Committee it is impossible to open or to complete the trial, **no refund of entries will be made.**

**Errors on entry forms.** Owners are responsible for errors in the completion of entry forms. Corrections cannot be made after the closing date. Please be certain that you select the right trial(s), fill in the right class(es) and have the correct jump height on your entries. No entry fee will be refunded in event of such errors or for cancellation of entries after the published closing date. Please type or print carefully on entry forms to avoid errors.

**Bitches in season will not be admitted to the Trial.** Any exhibitor with an entered bitch in season on the Trial date will be refunded the entry fee less \$5.00 (each day) upon written certification by a veterinarian given to the Trial Secretary before the start of judging each day.

**Exhibitors are responsible for the behavior of their dogs.** All dogs present must be confined to their crates except when being “pottied,” warmed up, or judged. Dogs being “pottied” or warmed up must be held on lead. Exhibitors are responsible for cleaning up after their dogs. Any exhibitor whose dog creates unnecessary disturbances or repeatedly engages in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any entry fees will be made.

**Crating will be on the west side of our building, which has easy access to the potty area. Judging will take place in the east suite of our building. Dogs that are not being shown or “on deck” to go in the ring must be crated on the west side of the building or secured in a climate-controlled vehicle.**

**Handlers WITHOUT THEIR DOGS are welcome to watch Rally Trial judging.** Rally Trial Committee Members will remind anyone with a dog that their dog must be crated while they are watching judging. The ring entrance and exit must be clear at all times. The Rally Trial Committee is committed to the safety of all dogs and handlers, and we thank you in advance for your support.

**Exhibitors and guests are responsible for the safety and behavior of any child(ren) who has/have accompanied them.** Any exhibitor or guest whose child or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any entry fees will be made.

**Judges will not wait for any dog holding up a class.** Owners or agents are responsible for the presence of their dogs in the judging ring when they are called to be judged. Dogs may arrive one hour prior to their scheduled walk-through. Dogs not required for further judging may be excused.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such injuries, death or property damage may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons.
